Paw Paw Days Food Vendor Rules

1. All food vendors should have their units in place after 4:00 p.m. on Friday, July 18, 2008.
2. All food vendors will be responsible for trash in their area. Bring trash cans for use by your patrons.
3. Food vendors may bring their own tables and chairs for use by their patrons.
4. No camping. City ordinance prohibits camping in public parks or parking lots.
5. All food vendors should be prepared for inspections by the Van Buren County Health Department on Saturday morning, July 19, 2008.

Fee and Insurance

The fee for participation as a food vendor in the 2008 Paw Paw Days is \$75.00. Please make all checks payable to the Paw Paw Chamber of Commerce. The participation fee must be returned with this signed contract no later than July 3, 2008.

Waiver of Liability

In submitting this application, applicants stipulate that the Paw Paw Chamber of Commerce, its agents, employees and representatives have made no representation, promises or guarantees regarding vending locations or preferential treatment of any kind.
